On behalf of the City of Morden, I extend a warm welcome to you and your family.


Few places in the world can offer the range of opportunities you will find here in terms of natural beauty, culture, education, recreation, housing, health care, business potential – in short, *quality of life*.





- Register for a Manitoba Health Card. With this card, you receive insured health care services free.
- ☑ Apply for Canada Child Tax Credit.
- ☑ Open a Bank Account at a bank or credit union.
- ☑ Organize a new Credit Card and Build Your Credit
- ☑ Find a family doctor who is taking new patients.
- ☑ Find a school for your children.
- ☑ Find a job.
- ☑ Set up your hydro, gas, telephone utilities.
- Arrange for postal service at Canada Post.
- ☑ Visit the Morden Civic Centre office to arrange your water, sewer and garbage collection.
- ☑ Apply for a Manitoba Drivers License.
- Arrange for Manitoba vehicle insurance.
- ☑ Visit the library and get a library card.

Morden is located in south central Manitoba in an area called the Pembina Valley, 112 km from Winnipeg's perimeter, 19 km from the U.S. border and 13 km from the City of Winkler. The exact geographic location is;


Manitoba Canada is in the Central Time Zone and observes Daylight Saving Time (DST), which begins on the second Sunday in March and ends on the first Sunday in November. DST is in place so that afternoons have more daylight. Clocks are turned ahead one hour in spring and turned back one hour in fall.

Currency

The Canadian Dollar is our national currency. Banknotes come in \$5, \$10, \$20, \$50, and \$100 denominations, which all have their own distinct colour. Coins include five cent (called a nickel); 10 cent (called a dime); 25 cent (called a quarter); one dollar (called a loonie); and two dollar (called a toonie).

Area Code

All telephone numbers in Manitoba must be 10 digits. The two area codes for Manitoba are 204 and 431. You have to first dial '1' before placing a long distance call and '011' when making an international call.



The history of Morden as a community dates back to 1882 when the Canadian Pacific Railway laid track across land owned by the Alvey Baker Morden Family. The Cheval Creek Station and water tower were built and later the town was named after Alvey Morden.

Fire Hall, Morden, Man

By 1884, residents of Nelson and Mountain City began to move houses, schools, churches and commercial buildings to Morden. By 1885 Morden was considered an important trading post for 50 miles around. Morden was incorporated as a village on May 1st, 1895. Mr. H.P. Hansen was elected as the first mayor. By 1903 Morden's population was 1500 allowing it to officially become a Town on Nov. 30, 1903. In 2011 Morden's population was 7,812 and on August 24th, 2012 Morden became a City.



Weather

All of our seasons are very clearly defined. Temperature and precipitation are measured in metric. Degrees Celsius (°C), Millimetres (mm), Centimeters (cm).

Spring (March 20th to June 20th)

Spring is always an exciting time in Morden, with the renewal of the vegetation, migratory birds flying back to nest, and the promise of warmer weather and longer days.

<u>Summer</u> (June 21st to September 21st) Summer is usually warm and sunny and can be hot at times.

<u>Fall</u> - Also called Autumn (September 22nd to December 20th)

Fall is cooler and more comfortable to many. The autumn leaves provide a truly natural spectacle. Snow can come as early as mid-October and usually begins to stay in early November.

Winter (December 21st to March 19th) Winter in Manitoba means bright and sunny skies and crisp, fresh air. During the winter months the temperature is usually below 0 Degrees Celsius, day and night. Temperatures can drop below -25 Degrees. It is important to learn about the dangers of the cold and how to stay warm. Wind chill often makes temperatures lower than they seem. Listening to local radio stations will help you to determine whether extra care should be taken with children when you send them to school or out to play. Schools will cancel classes for a day during the winter months if the weather is questionable or the wind chill is very high. Listening to the local radio stations will inform you if your child's classes have been cancelled for the day. (950AM, 93.5FM, 105.1FM, 88.9FM) Suggested winter wardrobe items are: a thick, wind-proof coat, scarf (for around your neck and/or across your face), gloves or mittens, winter hat that covers your ears and warm boots that are lined and/or waterproof.



As a resident of the City of Morden, you have access to the services and facilities in the City. The following three pages covers some of the important facts that you need to know.

Pet (Animal) Control

You are permitted to have domesticated animals, such as dogs and cats as pets, with the maximum allowed being two of each. You can help keep your pet safe by following these rules.

- All dogs must be licensed. You can purchase the license at the Morden Civic Centre.
- Animals are not allowed to run at large or trespass on public or private property. They must be contained on your yard or on a leash.
- Dogs are not allowed to disturb the peace by barking or howling.
- Dogs must be leashed when walking or exercising your pet.
- Please pick up waste if your animal has defecated on public or private property and dispose of it in a garbage can.

If your dog is not licenced and it is taken to the Morden Veterinary Clinic, there is a daily cost for the animal to be impounded. An additional fine plus a fee for a valid dog licence may also be charged. If your dog is licenced, then the licence fee will not be charged. All fees are paid at the Morden Civic Centre. If you have any questions about licensing your dog, please contact the Morden Civic Centre.



Community Compost Site

The compost site is located on Wilcocks Road. Acceptable compost items are - grass clippings, leaves and garden refuse - branches only. All items are to be placed in marked areas. We ask that you empty your plastic bags of the compost materials. Containers are provided if you want to dispose of them or you can take them with you. The compost is better if plastic bags don't get into the system.

Compost Weekly Pickup Service

Compost material is may be picked up on a weekly basis, every Monday, from May to September. To obtain this service residents are asked to purchase tags from the Morden Civic Centre at a fee of \$2.50 per bag with a maximum weight of 45 lbs per bag. The bags are to be placed at the curb by 8:00 am on Mondays.

Spring & Fall Cleanup

Compost material will be collected, free of charge, on your regular garbage pickup day during one week in April and one week in October. Exact dates are announced in the newspaper, or you can call the Morden Civic Centre at 204-822-4434. All items must be packed in boxes or plastic bags, branches must be cut and tied into bundles and placed at the curb prior to 8:00 am with no pickups after 5:00 pm.

Recycling

A blue recycling bin is provided free of charge to each household. If you require additional blue boxes or a replacement, you can pick it up at the Morden Civic Centre. We recommend that you clearly mark your address on the blue box. To find out what day recycling is picked up on your street, you can obtain a schedule at the Morden Civic Centre, or visit the website at www.mordenmb.com.

Solid Waste

Place your solid waste at the curb side by 6:00 am on your regular pickup day. Compost Material is not included in the solid waste pick up. There is a 2 bag limit – not to exceed 35 lbs each. Recycling is unlimited. Tags for extra solid waste bags are available at the Morden Civic Centre for \$2.00 per bag. For larger Items you are responsible to have them taken to the SWAMP site or contact Pembina Valley Containers (PVC) to arrange for disposal at your cost.



E-Waste

E-Waste disposal is FREE for households. Materials can be dropped off at Pembina Valley Containers - 160 Grant Street. Items that are accepted are:

Household Hazardous Waste Day

Every year householders in Morden, Winkler and RM of Stanley are given the chance to dispose of their Household Hazardous Waste. It is usually held the second Saturday in June. The drop off point alternates each year, between Winkler and Morden, please check the collection point address by visiting the Morden website at www.mordenmb.com or by calling 204-822-4434.

Landfill Site - SWAMP

The regional landfill site (SWAMP) is aimed at providing an environmental way of dealing with the waste from the entire region. Where possible, we encourage residents to practice 3R (Reduce, Reuse, Recycle) waste reduction, and to participate in recycling and composting programs in our communities. The SWAMP is located 4 miles North of PTH 14 on 428, 2 miles East, 3/4 mile North. For more information about SWAMP hours, fees, and what can be disposed of, please call 204-325-2216, or visit the Morden website where it is listed under City Services.

Snow Removal

Winter is a beautiful time of year in Morden, but we can get a lot of snow! It is important to understand how you can help with snow removal. The City of Morden Public Works Department tries to have the roadways cleared as quickly as possible. To do this they need your help.

- Please do not park vehicles on the streets. If you do park on the street you may receive a parking ticket, the vehicle could be towed away or your car could be buried in snow. The Overnight Parking Ban takes effect on the first snowfall of the year and parking is not allowed on the streets between the hours of 12:00 Midnight and 8:00 am.
- You cannot push snow onto the newly cleared street as this will cause obstructions and make it hard for vehicles to travel. This action may be subject to a fine.
- If you have questions or concerns about snow removal issues please call the hot line at the Public Works office at 204-822-5119.

Water & Sewer Utility Bills

Water & Sewer Utility Bills are prepared and mailed quarterly in March, June, September and December. There are two due dates on the Utility Bill. The 'Agency Date', which is the last date to use the Internet or Telephone Banking System. The 'Due Date' is the last date to have payment into the Morden Civic Centre office by 4:30 pm.

Any Utility Bill payments not received in the office by the due date will have a penalty calculated on the overdue amount of 1.25% until the bill is paid. Annually on February 1st all outstanding Water and Sewer accounts will be transferred to your Property Tax account.

Utility Bills for June, September and December are based on water meter readings, March bills are estimated based on past quarterly consumption. Door to door meter readings will be taken three times a year in May, August and November. When the meter reader is unable to gain access to read the meter, the utility bill is estimated. Water meter readings can be provided by residents to avoid an estimated billing. They need to be phoned/faxed/emailed into the Morden Civic Centre office by the 20th of the prior month. (e.g. for June, the deadline would be May 20th.) Water meter readings can be provided to the Morden Civic Centre by:

If you have questions about your utility bill, or how to read your water meter, please come to the Morden Civic Centre and the staff will help you.

We offer annual or monthly pre-authorized payment options and we accept internet and telephone banking payments.





Property Taxes

If you own a property in the City of Morden you will be required to pay property taxes each year. Ask your bank or lawyer to explain how much your taxes will be. You may also inquire at the Morden Civic Centre about your property taxes.

Tax bills are sent out in June and payment is due by 4:30 pm on the last business day in August. There will be a penalty of 1.25% calculated on the overdue amount every month thereafter. We offer annual or monthly pre-authorized payment options and we accept internet and telephone banking payments.

Business License

If you are a home based business in the City of Morden, or you plan on opening a business that will not be located in a commercially assessed property, you must obtain a Business License at the Morden Civic Centre. One of the benefits of having a business license is that your business will be listed on the Morden website online Business Directory.

Banking

Why open a bank account?

- To cash or write a cheque
- · To use bank machines or ATMs
- · It is safer than keeping your money at home
- It will improve your chances of being able to borrow money in the future
- · Your money can gain interest in a bank account.

Banks and Credit Unions

To open a bank account you will need at least two pieces of identification that show your signature and a photograph; such as a valid Passport, Permanent Resident Card, or a driver's license. You can open an account at banks or credit unions.

There are some differences between banks and credit unions. You must be a member at a credit union to use their services. You must buy a share (for a small fee of \$5) to be a member.

Automated Teller Machines

Most banks and credit unions have Automated Teller Machines (ATM's) that allow customers to perform everyday banking activities such as deposits, withdrawals, bill payments and transfers between accounts, 24 hours a day.

To use a banking machine, you require an ATM Card. This is a card the bank or credit union provides you, which allows you to use an ATM machine to get cash or it can also be used to buy items at a store without using cash. Everyone who has an ATM card also receives a Personal Identification Number (PIN), which is important to memorize and keep secret.

Bank Accounts

Chequing Account - A chequing account is useful for depositing the money you need for living expenses such as rent, bills, and shopping. You can withdraw the money any time you need it, or you can pay for your expenses with a cheque. If you don't have enough money in your account to cover a cheque that you write, the bank will refuse to cash it and will return it to the person you wrote the cheque to. You can be charged \$25 - \$40 or more for writing a cheque without sufficient funds (enough money) in your account.

Savings Account - A savings account is useful for depositing money you will not need to use right away. You can withdraw it at any time but while it is in your savings account you could collect interest on the money. Interest is based on a percentage of the money you have in the account and may be calculated on a daily, weekly or monthly basis.

Service Charges (Fees)

Banks and credit unions charge you for each service that you use, including the use of an ATM card and cashing cheques. These charges will vary from one institution to another and with different accounts. If you will be using such banking services regularly, it is a good idea to ask your bank or credit union about their service charges and choose the best plan for you.

Safety Deposit Boxes

You can rent a safety deposit box (SDB) in different sizes, depending on your needs. You pay an annual fee for SDBs. The amount you pay depends on the size of the box. You need two keys to open a SDB. The bank will give you one key and keep the second one. Because of this you can only access the SDB during branch hours. Be sure to keep your key in a safe place.




Canada Post

Canada Post Corporation provides most postal services in Canada. The Morden post office is located at 101 8th Street, and the hours of operation are Monday to Friday 9:00 am - 5:00 pm., Phone: 204-822-4694.

Letters and parcels can be picked up or delivered at the post office. Mailboxes for receiving mail at the post office are provided free of charge to Morden residents. You can also get a personal mailbox located at a Canada Post terminal located on the street near your home. The staff at the post office will tell you where your mailbox is and provide you with a key.

All letters must have a stamp, a return address and a mailing address which includes a postal code. A postal code in Canada is a 6 character set of numbers and letters. Example: R3G 4B5. Provinces can be abbreviated by 2 letter codes: MB is Manitoba.



You can buy stamps at any Post Office and at many stores. If you are unsure how many stamps you should use, ask at a Post Office. Parcels, packages, or overweight letters should be taken to a Post Office to be weighed before mailing them. If you do not know a postal code, you can ask your local post office to look it up for you or you can find it on the internet.

Telephone Services

Basic home telephone service in Manitoba is supplied by MTS. You can buy a phone from a store or you can rent a phone from MTS. After you find a place to live you can apply for basic phone service at the MTS Connect Store at 180B - 5th Street. To apply you will need 2 pieces of identification.

MTS offers Basic telephone services, Phone Rental, Answering Machine Services such as Call Answer, Call Waiting, Call Display, Dial Up and Highspeed Internet Access.

- Installation Fee To arrange for your telephone to be connected call MTS at 204-225-5687. You will be charged an installation fee to receive your own telephone number. This fee will be included on your first phone bill along with the first month's service fee.
- Your Telephone Bill You will receive
 a bill every month from MTS with
 charges for the different services you
 receive. If you use a different
 company for your long distance calls,
 you will receive a separate bill from
 that company. You can pay your MTS
 phone bill by mail, at the MTS
 Connect Store at 180B 5th Street, or
 at any banking institution in Town.
- Calling Long Distance Calls to
 Winkler and some rural areas are not
 long distance. Calls to Winnipeg are
 long distance. There is a chart in the
 front of the telephone book (White
 Pages) that gives you information on
 long distance telephone calls. It is
 less expensive to dial a long distance
 number on your own than to use an
 operator.
- Save Money on Long Distance Calls
 There are different long distance services in Manitoba. If you don't make a lot of long distance calls each month, basic MTS services should be sufficient. If you make a lot of long distance calls you can often save money by signing up for special long distance programs offered by MTS and other companies. It is best to ask several companies about their rates before choosing.
- <u>Directory Assistance</u> Dial 411 and an MTS operator can find a phone number for you. There is a small fee for this service, OR you can visit <u>www.411.ca</u> where you can find the information online.



Water Supply

The source of Morden's water is from Lake Minnewasta. It is treated at the City-owned Water Treatment Plant. The metre at your home measures the amount of water you use and you are billed quarterly based on consumption.

Sewage Treatment

The City's sewage treatment is through a Five-cell Lagoon System which is located east of the City. Quarterly bills for the sewer along with the water bills are mailed out in March, June, September and December.



Garage Sales

During the warmer months of the year, many people have garage sales and yard sales or auctions where they sell secondhand clothing, furniture, toys and household items. Garage Sale information can be found in the newspaper and on the Garage Sale Notice Board located at the City parking lot just west of the 55+ Activity Centre on North Railway Street. If you would like to hold a Garage Sale and post it on the board, there are signs available, free of charge, at the Morden Civic Centre at 195 Stephen Street.

Farmers Market

Every Thursday between June & October, there is a weekly Farmers Market held downtown from 4:00 pm - 6:30 pm, weather permitting. Morden Farmer's Market offers the best in locally produced meats, vegetables, baking and many other products.

Second Hand Stores

To save money on household items, clothing and furniture, many people shop at second hand stores. The Morden Community Thrift Shop located at 220 North Railway Street is run by volunteers and offers second hand articles. Many community projects are supported by the money raised.

There are a variety of restaurants in Morden that offer fast food and family-style dining. Restaurants are listed on the Morden website. It is customary to leave a tip of 10% to 15% at restaurants that are not fast food restaurants.

HOUSING

Renting

Apartments in Morden are usually rented according to the number of bedrooms they have.

All apartments must have a kitchen with a refrigerator and an oven. Sometimes utilities such as water, hydro (electricity), or natural gas (if used for heating) are included in the rent. You will have to pay extra if you want cable television. Parking fees are usually included in your rent. Check to see how many vehicles you are allowed to park and how many plug-ins you have. Vehicles in the winter months may require to be plugged in to operate properly.

Definitions & Points About Renting

- Tenant: A person who lives in a place that is rented.
 Tenants may be responsible for upkeep of property both inside and out, including mowing lawns, etc.
 Check with the landlord BEFORE you move in.
- Landlord: This is a person who owns the building and rents it out to people.
- Caretaker: This is a person the landlord hires to keep the building clean and to do repairs. He/She may be the person you talk to when you are looking for a place to live. In larger buildings, this person may be called the Manager or Superintendent.
- Rent: Rent is the money a tenant pays the landlord or caretaker every month. Be sure you know whom to pay rent to. It is best to pay by cheque made payable to the owner.
- Pro-Rated Rent: If you move into a place in the middle of a month, you only need to pay for the number of days remaining for the month. For example, if your rent is \$400.00 a month and you move in on the 15th, your prorated rent would be \$200.00 for your first month.
- Damage Deposit: This is money you pay a landlord before you move in. It pays for cleaning or repairs that must be done to the apartment or house after you move out. It usually equals half of one month's rent. If you want to get your damage deposit back when you move out, you must:
 - leave the place in the same condition it was in when you moved in,
 - clean the house or apartment before you move out, and
 - give proper notice in writing before you move out (minimum 30 days).



Rental Applications

If you like an apartment you see, you may first have to complete an Application Form. The landlord or caretaker will consider all the applications they receive and then decide who will rent the apartment.

Tenancy Agreements

If your application is accepted, you sign a Tenancy Agreement with the landlord. You agree to pay a certain amount of rent every month, and agree to certain living arrangements. Make sure you know:


- which utilities are included (gas, hydro, water, cable),
- · if you have to pay for parking,
- if pets are allowed,
- is smoking allowed,
- · the date rent is due.

If the landlord asks you to sign a lease, it means you must agree to live in the apartment for the specified period of time.

Condition Report

You should ask to sign a Condition Report, which shows the condition of all the rooms and appliances in the house or apartment before you move in. You should inspect everything listed in the condition report with the caretaker to make sure it is not already damaged. If something is damaged before you move in, this is a good time to ask the landlord to fix it.





Paying Rent

It is best for your own records to pay by cheque. The landlord or caretaker will tell you where to pay rent when you move in. You should ask for a receipt if you are paying your rent in cash.

Moving Out

All agreements will specify how much advance notice you must give a landlord before you can move out. If you are renting month-to-month you may have to give the landlord notice in writing, one or two months before you want to move out. If you signed a lease you will have to stay until the lease period is finished or sublet (rent) the apartment to another tenant. Subletting the apartment can be done only after the landlord gives approval.

Buying Your Own Home

Homes can be purchased with CMHC (Canada Mortgage and Housing Commission) approval with a 5% down payment (if the home and the applicant meet certain criteria). For more information visit www.cmhc-schl.gc.ca or ask your financial institution (bank or credit union).

Homes can be purchased with 5% to 25% down payment depending on the financial institution chosen by the purchaser.

A prospective buyer will also have to pay legal fees and other possible fees. Homes can be purchased through various Real Estate Agents in Morden or privately with the help of a lawyer.

Drinking

 The legal age for drinking alcohol in Manitoba is 18. It is illegal to serve alcohol to minors (anyone under 18) in bars, restaurants and other public places.

It is illegal to drink alcohol in public places such as streets or parks.
 You may drink in your own home and on your own property. It is illegal to drink alcohol in your car.

It is illegal to drink and drive. The police are allowed to give a
breath test to drivers suspected of drinking and driving. Persons
caught driving a vehicle with a blood alcohol level over the
allowed limit will lose their license and also lose the right to
drive for three months or longer and your vehicle may be taken
away. Anyone caught driving while their license is suspended
will have their vehicle taken away.

Smoking

- In Manitoba, you must be 18 years old to buy cigarettes.
- Smoking is not allowed in government offices and public buildings such as schools, banks, stores and restaurants.
- It is illegal to smoke in vehicles when children under 16 years of age are present. This applies to all lighted tobacco products.

Relationships

- The law in Manitoba supports the use of reasonable force but discourages parents from using harsh physical punishment on their children. It is against the law to punish children so harshly that you leave marks on a child's body.
- It is against the law to leave children at home alone unless they are 12 years old. Babysitters must be at least 12 years old.
- Manitoba has a zero tolerance policy towards domestic abuse. This
 means that violence in the home against spouses and children is a
 crime. The police MUST charge individuals for domestic abuse even if
 the spouse does not wish to proceed with charges. It is not up to the
 spouse if they wish to proceed with charges.
- It is illegal to have sexual relations with a minor under the age of 16
 and illegal to solicit the services of a prostitute.



LAWS IN MANITOBA

All vehicles licensed in Manitoba MUST HAVE a valid safety inspection certificate. A safety certificate is valid for one year from the date of issue and states that the condition of a vehicle has been brought to a set standard at the time of the issue. Just because a safety certificate is still valid does not mean a vehicle is still safe to drive. If you are buying the vehicle near the expiry of the safety certificate, the condition of the vehicle may have deteriorated to an unsafe condition. It is a good idea to pay a mechanic to check the condition of any vehicle before you buy it. Once you have registered your vehicle with a valid safety certificate, you do not have to have your vehicle re-inspected for as long as you own it.

When you buy a new vehicle from a dealership it will automatically have a valid safety certificate and you will pay all taxes to the dealership.

When buying a used vehicle from a dealership it will most likely have the safety certificate included but you should ask. When buying a vehicle from a private individual, make sure to ask whether the vehicle has a valid safety certificate. You will have to pay the tax on the used vehicle when you register it.

 In order to drive legally in Manitoba, you must have a valid driver's license from Manitoba or your country of origin. You need to apply for your Manitoba Driver's License as soon as possible upon arrival in Morden. Legally you must obtain a Manitoba Driver's License within 3 months of your arrival. You must carry your license at all times when you will be driving. If caught driving without your license, you can be fined.

Vehicle Insurance

The Manitoba government sets vehicle insurance rates and it is called Autopac. You can purchase insurance from different Autopac agencies, but the rates remain the same. In Manitoba, you will receive merits for a good driving record and lose merits with a poor driving record. Your merit status will influence the amount you will pay for vehicle insurance. You can get up to 25% discounted from your car insurance premium if you have no merits. To receive your merit standing in Manitoba, you will need two documents.

- 1. A letter from your insurance company stating that you have had no claims.
- A Driver's Abstract from the government of your former country verifying your driving record.

Be careful to insure a vehicle for the purpose it is to be used for. Example, if you are going to use the vehicle for work purposes, it must say so on your insurance policy in order for you to have coverage while you drive to work and while you are working.



Canada Child Tax Benefits (CCTB)
The Child Tax Benefit is a federal
government program that provides
monthly payments to help you with the
cost of raising children. This program is
for parents with children under 18
years of age. Payment is made to the
parent who has the responsibility for
the child's care and upbringing. In most
cases, the mother of the child is
considered to be that person.

The amount of monthly Canada Child Tax Benefit is based on your family income for the previous year. If you are eligible, a letter that shows the amount of your monthly payment for each child will be sent to you. It takes a few months to receive this benefit, after application.

Manitoba Child Benefit Program (MCB) The Manitoba Child Benefit Program is a provincial government program that helps low income families with dependent children under 18 years of age.

The amount of money you will receive depends on your yearly family income. Maximum benefit per child is \$35.00. You must also be receiving your Canada Child Tax Benefit before you can apply for this support.

An application must be completed each year to determine eligibility. You are not able to receive this benefit and Social Assistance at the same time. To apply call: 1-800-563-8793

Medical Card

Most medical services are paid for by Manitoba Health and are available to all returning Canadians, permanent residents and valid work permit holders in Manitoba. To be able to access these services you must apply for insurance through Manitoba Health. You may receive health care benefits from the first day of your arrival if you have identification.

Coverage will begin on the first day of the third month after your arrival in Manitoba. For example, if you arrive on April 29, April will count as the first month, with May and June as the following two. Therefore, in this case your coverage would begin July 1.



Manitoba Health issues a card to all Manitoba residents, which includes a 9-digit lifetime identification number. Each person in your family (under the age of 18) will be listed on your

card and will have their own Personal Health Identification Number(PHIN). Anyone over the age of 18 must apply for their own Medical Card. We advise that you carry your certificate with you at all times and present it whenever you or your dependants require health services.

Please report a new address, a marriage, birth, adoption, death, divorce or legal separation to Manitoba Health. If you lose your certificate, be sure to write or telephone Manitoba Health for a replacement.

The cost of dental care, eye glasses and medication are not covered by Manitoba Health.

Emergency Medical Services

Emergency Medical Services are available at the Boundary Trails Health Centre (hospital) located at the intersection of Highway 3 and Highway 14 between Morden & Winkler.

The Emergency Service is open 24 hours a day and should only be used in emergencies. Ambulance service IS NOT covered by the government and will cost you more than \$200. An ambulance should be called in life-threatening situations. Dial 911 if there is an emergency.

Walk In Clinics

If you need to see a Doctor quickly, Agassiz Medical Centre, located at 115-30 Stephen Street, has walk in clinics Monday to Friday 11:30 am to 7:30 pm. Whenever you go to a clinic or emergency room you will be asked for your Manitoba Health Card.

Family Doctors

One of the first things you need to do is find yourself a doctor. Most people in Canada have a family doctor who they see for general health problems or for regular check-ups. If necessary, the doctor can refer you to a specialist for special health problems. You must make an appointment to see a family doctor or a specialist. If you have health records from your country or province, bring them with you to show to your new doctor. This is especially important if you or your family requires immunizations or special treatment.





Register Your Child

When registering your child the school will need proof of residency (such as a utility bill or lease agreement), proof of your

child's date of birth, and a completed school registration form including your child's health card number.

The earlier the principal is aware of a new student's arrival, the better prepared the school can be. Advance notice gives school staff time to meet with you to find out more about your family so that the transition into school will be successful.

Usually children start going to school when they are four or five and must attend school until the age of 15 or 16. Kindergarten remains an optional year of schooling. Parents and Guardians are encouraged to register their children who are five years old before December 31st at the school of their choice.



Morden Adult Education Centre

Red River Technical Vocational Area (R.R.T.V.A.)

The RRTVA is a partnership of five southern Manitoba school divisions devoted to providing technology education options to high school students in the region.

Think of RRTVA as a 'virtual' regional technical school. Instead of one large building there are six locations that have from one to six technical programs. Students have a 'home' and 'away' semester. The required core credits are earned in the students 'home' school. During the 'away' semester, they are bused to the school that offers the program of their choice. They can earn anywhere from four to twelve credits toward graduation in a technical program.

Social Insurance Number

A Social Insurance Number (SIN) is your personal identification number issued by the Government of Canada. You need to have a Social Insurance Number to work in Canada. It can also help you to open a bank account and cash cheques.

To apply for your SIN you will need to take one of the following documents to the Service Canada Centre located in Morden at 158 Stephen Street. You will be required to show:

- Canada Immigration Record and Visa or Record of Landing (IMM 1000)
- Visitor Record, Employment Authorization or Minister's Permit Extension (IMM 1442 or equivalent)
- Refugee Status Claim (IMM 1434)

You must take original documents or copies of the documents that are certified by Notary Public or a Commissioner of Oaths to prove they are exact copies. While you are waiting for your Social Insurance Number to arrive you may still apply for jobs by showing a copy of your application.

Income Tax

Every year Canadians need to file an Income Tax Return with the Canadian Government.

Canada's tax systems pay for roads, public utilities, education, health care, economic development, cultural activities, defence, law enforcement, and many other services and programs.

Any person who is employed and collects a paycheque must submit an income tax return each year. One parent should submit an income tax return in order to receive GST and Child Tax Credit benefits from the government.

Generally, your tax return has to be filed on or before April 30th each year. It is a good idea to start the process early every year to make sure that your return is finished in time.

There are 2 ways that you can prepare your Income Tax Return.

- 1. Do it yourself;
- 2. Pay for an Accountant or a Bookkeeper to prepare it for you.

To prepare your Income Tax Return yourself, you can pick up the free booklet and forms at the Post Office, located at 101-8th Street. If you would like to pay a professional to prepare your return, look in the phone book for an Accountant, Bookkeeper, or under Income Tax Return Preparation in the Yellow Pages of the phone book.


